**Re: Credit Union Information Seminars 2013 – New Regulatory Framework**

Dear Chairman,

We are pleased to announce that we will be holding a series of Information Seminars for credit unions in July this year. The purpose of the Information Seminars is to assist credit unions in preparing for the introduction of the new strengthened regulatory framework which includes the Fitness and Probity regime for credit unions and the new prudential and governance requirements contained in the Credit Union and Co-operation with Overseas Regulators Act 2012.

**Fitness and Probity**

Further to consultation, the Fitness and Probity regime for credit unions will be introduced on a phased basis with transitional arrangements. The first phase will apply to all credit unions with assets greater than €10 million and will commence on 1 August 2013. The final Regulations, Standards, Guidance and related Individual Questionnaire will be circulated by e-mail to credit unions and will also be provided on the Central Bank website in advance of the Information Seminars. The Information Seminars will provide details on the requirements for credit unions arising from the introduction of the Fitness and Probity regime for credit unions. Further support material will also be provided on the Central Bank website.

**Requirements Contained in the Credit Union and Co-operation with Overseas Regulators Act 2012**

The Credit Union and Co-operation with Overseas Regulators Act 2012 contains new governance and prudential requirements for credit unions that will apply to all credit unions when commenced. The Central Bank is developing a Credit Union Handbook which will support credit unions in their implementation of the new requirements. The Information Seminars will provide details on the Central Bank's plans for the introduction of the Credit Union Handbook.

The schedule of Information Seminars is set out below. Please note that two sessions will be held at every location in order to provide attendees with a choice of times.




