

DAMAGED € EURO COINS ONLY

Damaged coins can be submitted for value exchange via the drop box located at the Central Bank of Ireland in North Wall Quay, or by post. Please sort your submission in advance as follows:



Damaged euro coins are submitted for exchange in accordance with EU <u>Regulation (EU) No 1210/2010</u> of the European Parliament. (1210/2010 concerning authentication of euro coins and handling of euro coins unfit for circulation)

Submissions must include:

- **1.** Completed form **2.** Bank account details for payment
- 3. A copy of photographic ID for submissions over €100

Postal submissions must be sorted as outlined above with coins and notes sealed in separate envelopes. Please address to Central Bank of Ireland, PO Box 61, P3, Sandyford, Dublin 16


