**Banco Santander, S.A.**

Issue of EUR 50,000,000 Floating Rate Instruments due January 2023

Series 7 – Second Ranking Senior Tranche 5 (to be consolidated and form a single series with the existing EUR 100,000,000 Floating Rate Instruments due January 2023 issued on 5 May 2017 as Series 7-Second Ranking Senior Tranche 1 (the “Tranche 1 Instruments”), the existing EUR 50,000,000 Floating Rate Instruments due January 2023 issued on 19 May 2017 as Series 7-Second Ranking Senior Tranche 2 (the “Tranche 2 Instruments”), the existing EUR 135,000,000 Floating Rate Instruments due January 2023 issued on 2 June 2017 as Series 7-Second Ranking Senior Tranche 3 (the “Tranche 3 Instruments”), and the existing EUR 50,000,000 Floating Rate Instruments due January 2023 issued on 15 June 2017 as Series 7-Second Ranking Senior Tranche 4 (the “Tranche 4 Instruments” and, together with the Tranche 1 Instruments, the Tranche 2 Instruments and the Tranche 3 Instruments, the “Existing Instruments”) under the €25,000,000,000 Programme for the Issuance of Debt Instruments

The Base Prospectus referred to below (as completed by these Final Terms) has been prepared on the basis that any offer of Instruments in Ireland or any Member State of the European Economic Area which has implemented the Prospectus Directive (2003/71/EC), as amended, (each, a “**Relevant Member State**”) will be made pursuant to an exemption under the Prospectus Directive, as implemented in that Relevant Member State, from the requirement to publish a prospectus for offers of the Instruments. Accordingly, any person making or intending to make an offer in that Relevant Member State of the Instruments may only do so in circumstances in which no obligation arises for the Issuer or any Dealer to publish a prospectus pursuant to Article 3 of the Prospectus Directive or supplement a prospectus pursuant to Article 16 of the Prospectus Directive, in each case, in relation to such offer. Neither the Issuer nor any Dealer has authorised, nor do they authorise, the making of any offer of Instruments in any other circumstances.
