The undersigned:

 grounds for the Central Bank of Ireland to commence an administrative sanctions
 procedure against both him/herself and/ or the proposing entity to knowingly or
 recklessly: a. Provide false or misleading information and/ or to make a false or

- misleading statement (which s/he acknowledges, may include the withholding by me of relevant information) in this application for approval; b. Fail to inform the Central Bank of Ireland and/ or withhold from the Central Bank of Ireland or the ECB details of any material change in circumstances/ new information which is relevant to the status of the proposed approved person;
- certifies that the documents provided as annexes are a true copy of the documents kept in the archives of the supervised entity and provided by the appointee and the supervised entity itself;
- confirms that s/he has authority to make this notification/application and provide the declarations given by the Supervised Entity, and sign this form on behalf of, the supervised entity;
- declares to be aware of the processing and storage of personal data in accordance with the applicable data protection regulation and <u>the privacy</u> <u>statement of the ECB</u>.
